Important Notifications from WNY DISTRICT OF

Notice of Special Enrollment Rights

If you are declining enrollment for yourself and your dependents (including your spouse) because of other health insurance or group health plan coverage, you may in the future be able to enroll yourself and your dependents in this plan if you or your dependents lose eligibility for that other coverage. However, you must request enrollment within 30 days after other coverage ends or your dependents' other coverage ends.

If you have a new dependent as a result of marriage, birth, adoption, or placement for adoption, you may be able to enroll yourself and your dependents. However, you must request enrollment within 30 days after the marriage, birth, adoption, or placement for adoption.

You have two additional special enrollment opportunities. If you or your dependent's Medicaid or Children's Health Insurance Program (CHIP) coverage ends as a result of loss of eligibility, you may enroll in the benefits plan. If you or your dependent becomes eligible for a premium assistance subsidy under Medicaid or CHIP, you may elect to enroll in the subsidized plan and cancel coverage in the **WNY DISTRICT OF THE WESLEYAN CHURCHES** benefit plan. You must request enrollment within 60 days of the loss of eligibility of Medicaid or CHIP or becoming eligible for premium assistance subsidy. To request special enrollment or obtain more information, contact your local Human Resources Department or your local Medicaid or CHIP program.

COBRA Notification

The Consolidated Omnibus Budget Reconciliation Act (COBRA) of 1985 was enacted to allow employees to extend coverage when status changes. A COBRA General Notice is provided to you when you are first covered under the medical, dental, or vision plan. The COBRA General Notice explains your right to participate in the Group Health Plan. When you terminate coverage, a COBRA Election Notice will be provided.

If your status as a full-time employee changes, your dependent loses coverage, or you terminate employment, COBRA allows you to extend your coverage for up to 18 months (and up to 36 months in New York State, under special circumstances) when you pay 102% of the full premium for medical, dental, and vision coverage.

Medicaid and Children's Health Insurance Program (CHIP) Notice

If you are eligible for health coverage from your employer, but are unable to afford the premiums, some States have premium assistance programs that can help pay for coverage. These States use funds from their Medicaid or CHIP programs to help people who are eligible for employer-sponsored health coverage but need assistance in paying their health premiums.

If you or your dependents are already enrolled in Medicaid or CHIP and you live in a State listed, you can contact your State Medicaid or CHIP office to find out if premium assistance is available.

If you or your dependents are **NOT** currently enrolled in Medicaid or CHIP, and you think you or any of your dependents might be eligible for either of these programs, you can contact **your State Medicaid or CHIP office or dial 1-877-KIDS NOW or www.insurekidsnow.gov** to find out how to apply. If you qualify, you can ask the state if it has a program that might help you pay the premiums for an employer-sponsored plan.

Once it is determined that you or your dependents are eligible for premium assistance under Medicaid or CHIP, your employer's health plan is required to permit you and your dependents to enroll in the plan – as long as you and your dependents are eligible, but not already enrolled in the employer's plan. This is called a "special enrollment" opportunity, and **you must request coverage within 60 days of being determined eligible for premium assistance.**

The Women's Health and Cancer Rights Act

The Women's Health and Cancer Rights Act (WHCRA) provides protections for individuals who elect breast reconstruction after a mastectomy. As required by law, the following is the Women's health and Cancer Rights Notice.

NOTICE

Do you know that your plan, as required by the Women's Health and Cancer Rights Act of 1998, provides benefits for mastectomy-related services including all stages of reconstruction and surgery to

achieve symmetry between the breasts, prostheses, and complications resulting from a mastectomy, including lymphedema? These benefits will be provided subject to the same deductible and coinsurance applicable to other medical and surgical benefits provided under this plan. Call your Human Resources Department/Plan Administrator for more information.

The Newborns' Mothers' Health Protection Act

The Newborns' and Mothers' Health Protection Act (the Newborns' Act) provides protections for mothers and their newborn children relating to the length of their hospital stays following childbirth.

Group health plans and health insurance issuers generally may not, under federal law, restrict benefits for any hospital length of stay in connection with childbirth for the mother of newborn child to less than 48 hours following a vaginal delivery, or less than 96 hours following a cesarean section. However, Federal law generally does not prohibit the mother's or newborn's attending provider, after consulting with the mother, from discharging the mother or her newborn earlier than 48 hours (or 96 hours as applicable). In any case, plans and issuers may not, under Federal law, require that a provider obtain authorization from the plan or the insurance issuer for prescribing a length of stay not in excess of 48 hours or 96 hours.

Genetic Information Nondiscrimination Act (GINA)

The Genetic Information Nondiscrimination Act of 2008 makes it illegal for the group health plans and health insurers to deny coverage to healthy individuals, impose a preexisting condition limitation, or charge higher premiums based solely on the basis of genetic information. Additionally, group health plans cannot request any individual or family member to undergo genetic testing. GINA restricts the collection of genetic information and requires plans to treat genetic information as "protected health information."



Important Notifications from **WNY DISTRICT OF**

Medicare Part D Notice of Creditable Coverage

Please read this notice carefully and keep it where you can find it. This notice has information about your current prescription drug coverage with **WNY DISTRICT OF THE WESLEYAN CHURCHES** and about your options under Medicare's prescription drug coverage. This information can help you decide whether or not you want to join a Medicare drug plan. If you are considering joining, you should compare your current coverage, including which drugs are covered at what cost, with the coverage and costs of the plans offering Medicare prescription drug coverage in your area. Information about where you can get help to make decisions about your prescription drug coverage is at the end of this notice.

There are two important things you need to know about your current coverage and Medicare's prescription drug coverage:

1. Medicare prescription drug coverage became available in 2006 to everyone with Medicare. You can get this coverage if you join a Medicare Prescription Drug Plan or join a Medicare Advantage Plan (like an HMO or PPO) that offers prescription drug coverage. All Medicare drug plans provide at least a standard level of coverage set by Medicare. Some plans may also offer more coverage for a higher monthly premium.

2. **WNY DISTRICT OF THE WESLEYAN CHURCHES** has determined that the prescription drug coverage offered by the **Independent Health** plan(s) are, on average for all plan participants, expected to pay out as much as standard Medicare prescription drug coverage pays and is therefore considered Creditable Coverage. Because your existing coverage is Creditable Coverage, you can keep this coverage and not pay a higher premium (a penalty) if you later decide to join a Medicare drug plan.

When Can I Join a Medicare Drug Plan?

You can join a Medicare drug plan when you first become eligible for Medicare and each year from October 15 to December 7.

However, if you lose your current creditable prescription drug coverage, through no fault of your own, you will also be eligible for a two (2) month Special enrollment Period (SEP) to join a Medicare drug plan

What Happens to my current coverage if I decide to join a Medicare drug plan?

If you decide to join a Medicare drug plan, your current **WNY DISTRICT OF THE WESLEYAN CHURCHES** coverage will not be affected. If you do decide to join a Medicare drug plan and drop your current **WNY DISTRICT OF THE WESLEYAN CHURCHES** coverage, be aware that you and your dependents will not be able to get this coverage back. Re-enrollment in **WNY DISTRICT OF THE WESLEYAN CHURCHES** coverage will be limited to Open Enrollment unless a qualified change in status even occurs.

When will I pay higher premium (penalty) to join a Medicare drug plan?

You should also know that if you drop or lose your current coverage with **WNY DISTRICT OF THE WESLEYAN CHURCHES** and don't join a Medicare drug plan within 63 continuous days after your current coverage ends, you may pay a higher premium (a penalty) to join Medicare drug plan later.

If you go 63 continuous days or longer without creditable prescription drug coverage, your monthly premium may go up by at least 1% of the Medicare base beneficiary premium per month for every month that you did not have coverage. For example, if you go nineteen months without creditable coverage, your premium may consistently be at least 19% higher than the Medicare base beneficiary premium. You may have to pay this higher premium (a penalty) as long as you have Medicare prescription drug coverage. In addition, you may have to wait until the following October to join.

Premium Assistance Under Medicaid and the Children’s Health Insurance Program (CHIP)

If you or your children are eligible for Medicaid or CHIP and you’re eligible for health coverage from your employer, your state may have a premium assistance program that can help pay for coverage, using funds from their Medicaid or CHIP programs. If you or your children aren’t eligible for Medicaid or CHIP, you won’t be eligible for these premium assistance programs but you may be able to buy individual insurance coverage through the Health InsuranceMarketplace. For more information, visit www.healthcare.gov.

If you or your dependents are already enrolled in Medicaid or CHIP and you live in a State listed below, contact your State Medicaid or CHIP office to find out if premium assistance is available.

If you or your dependents are NOT currently enrolled in Medicaid or CHIP, and you think you or any of your dependents might be eligible for either of these programs, contact your State Medicaid or CHIP office or dial **1-877- KIDS NOW** or www.insurekidsnow.gov to find out how to apply. If you qualify, ask your state if it has a program that might help you pay the premiums for an employer-sponsored plan.

If you or your dependents are eligible for premium assistance under Medicaid or CHIP, as well as eligible under your employer plan, your employer must allow you to enroll in your employer plan if you aren’t already enrolled. This is called a “special enrollment” opportunity, and **you must request coverage within 60 days of being determined eligible for premium assistance**. Paperwork Reduction Act Statement
